MEMORANDUM OF UNDERSTANDING (MOU) BETWEEN

COLLABORATION IN THE FIELD OF RESEARCH, EDUCATION & TRAINING
AND FACULTY EXCHANGE

Preamble:

The Memorandum of Understanding is a bridge made between the “**APT Research Foundation, Pune-411041**” and “**Rajarshi Shahu College of Pharmacy, Buldana-443001**” is witnessed as follows:

Recognizing the mutual interest in the fields of research, development, educational training, and other facilities & dissemination of knowledge on long term basis.

Recognizing the importance of the role of an Institute in tertiary care in promoting national and international collaboration and increasing contribution to social development services.

Hereby the parties agree to establish collaboration in research, education and training during the pendency of MOU according to terms and conditions set out in the articles following hereunder.

The words “The two parties/Institutions” and “collaborating parties/Institutions” in the Memorandum of Understanding refer to “**APT Research Foundation, Pune**” and “**Rajarshi Shahu College of Pharmacy, Buldana-443001**”.

Hereafter ‘**APT Research Foundation**’ will be referred as “**PARTY I**” and “**Rajarshi Shahu College of Pharmacy, Buldana-443001**” will be referred as “**PARTY II**”

Article-1: FIELD OF COLLABORATION

Collaboration between the two institutions may be established within any field related to health science and technology of mutual interest and in particular research and patient care. Party I shall provide animal house facility for pharmacological , Toxicological and other preclinical studies to Party II to run the post graduate course with prior permission from APT Testing and Research Pvt. Ltd, Pune 41. Extensions to other areas will be made through further amendments to the present Memorandum of Understanding.

Article-2: EXCHANGE OF STAFF AND STUDENTS

2.1 Faculty and students of either institute, who wish to undertake a short term program or training or field work or research work at the other institution, will be assisted by the host institution in getting authorization, library and laboratory facilities; provided the program is accepted by the home institution and by at least one supervisor from each institution.

2.2 There is possibility of twinning faculty and students of the two institutions in common research.

2.3 Parties will exchange proposals concerning the topics, persons, type of research, tests and periods of specific research reasonably in advance of the proposed visit.

Article-3: SHARING SCIENTIFIC BODIES

Scientific statutory bodies like Scientific Advisory Committee (SAC), Institutional Ethics Committee (IEC) and Animal Ethics Committee of the parties will be shared by both of them for the combined research projects.

Article-4: TRAINING OF STUDENTS

Both parties (I &II) will provide facilities for observation and practical training for students of other party. This training will be for a minimum duration of one month. **The training fees and the cost of research projects with travel and/or living allowances to these students will be provided by the student himself/herself.** The selection of the student will be need based. Suitable and adequate accommodation will be provided, subject to the availability. But in any case it does not cause any financial liability on part of the host institute.

Article-5: JOINT SUPERVISION OF STUDENT PROJECT

5.1 As a part of collaboration, the faculty of both parties may jointly supervise research projects of students.

5.2 The details of the project of students will be worked out by the respective persons of both the institutions.

5.3 The student should first submit the project proposal which has to be authorized by both the institutions.

Article-6: RESEARCH PROJECTS

6.1 Efforts will be made to write and conduct research project by both institutions and provide information about ongoing research activities in order to establish contacts and collaborations between professionals working within the same field.

6.2 Research projects and the composition of research teams will be approved by both the institutions. Efforts will be made to evaluate the need for participating staff and location of the research activity.

6.3 Each research project will be jointly led by both institutions' team leader, who will be responsible for reporting on the project status.

Article-7: INTELLECTUAL PROPERTY RIGHTS (IPR)

7.1 All intellectual property solely conceived and/or developed by PARTY I during the course of this agreement shall be owned by PARTY I.

7.2 All intellectual property solely conceived and/or developed by PARTY II during the course of this agreement shall be owned by PARTY II.

7.3 Intellectual property jointly conceived and/or developed by PARTY I and PARTY II will be jointly owned by PARTY I and PARTY II. Both PARTIES I and II agree towards the protection when the application of such intellectual property for commercial or other purposes on mutually acceptable terms with equal shares. All the provisions of this article hold true only for exchange of the students/faculty to other institution.

Article-8: FUNDING AND FINANCE

The party doing the research project will have the responsibility to finance the project & the other party in which the project is been carried out will provide the infrastructure and other related facilities. The exact nature of funding and finance to be decided mutually at the starting of each project.

Article-9: LINK MANAGEMENT AND ADMINISTRATION

Negotiation, Implementation and co-ordination of the Memorandum of Understanding falls under the responsibility of both, the Head of Institution of the PARTY I and the Principal of PARTY II. The MOU will take effect from the date it is signed by the Head of the Institution of the PARTY I, and the Principal of the PARTY II.

Article-10: GENERAL PROVISIONS

10.1 The two institutions will carry out joint research as a follow up to this Memorandum of Understanding. The activities must be carried out in accordance with appropriate laws and regulations existing in country and will undertake to not violate any of the statutory requirements as laid by the concerned bodies appointed by the government for time to time..

10.2 The two institutions shall initiate an exchange of research publications, publication lists and other official publications. This will be provided with adequate security as for as intellectual property laws are concerned as mentioned in article No. 7.

10.3 All publications resulting from the collaboration between the two institutions will be mentioned in the scientific reports of the institutions. Likewise, this Memorandum of Understanding must also be mentioned in all formal presentation,

which results from the collaboration under the terms of this Memorandum of Understanding.


10.4 This Memorandum of Understanding is signed subject to appropriate authorization both sides.

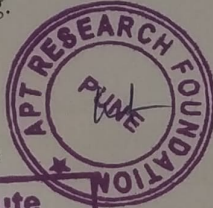
Article-11: NON-DISCLOSURE







DMIMS (Deemed to be University) and Rajarshi Shahu College of Pharmacy, Buldana (Maharashtra) agree to collaborate towards the protection, if the application of such intellectual property for commercial or other purposes on mutually acceptable terms with equal shares.

Article-7: LINK MANAGEMENT AND ADMINISTRATION:

RECITALS

1. Rajarshi Shahu College Of Pharmacy , Buldana is engaged inter alia in Academic Teaching and Research in Pharmaceutical Sciences is mentioned in Annexure -A
2. Mprex Healthcare Private Limited is engaged inter alia in the business of Contract research services which includes services is mentioned in Annexure -B
3. The object of the agreement is to arrive and have an arrangement/understanding/agreement between the both the parties utilize each other potential expertise and only within such limitations relating to price, delivery.
4. This agreement is on a non-exclusive basis and both parties’ reserves the right to enter into similar kind of agreement on the same, or different terms and conditions at their sole discretion.
5. There will be separate project specific agreements for all business exchange between two parties and financial part will be dealt in these project specific agreements.
6. Rajarshi Shahu College Of Pharmacy , Buldana and Mprex Healthcare Private Limited wish to exchange with each other certain confidential information for the purpose of evaluating the possibility of having a mutually beneficial business relationship.

For the purpose of furthering a potential business relationship between them, Rajarshi Shahu College Of Pharmacy, Buldana and Mprex Healthcare Private Limited (collectively referred to as the "Parties," and individually referred to as a "Party") have determined to establish terms governing the use and protection of certain information one Party ("Owner") may disclose to the other Party ("Recipient"). This activity is for the execution of different courses for different strengths to improve the academic performance of students and value addition to performance of the students.

NOW, THEREFORE, in consideration of the mutual promises and covenants contained in this Agreement, the Parties, intending to be legally bound, agree as follows:

1. Definitions.

a) "Affiliate" means any person or entity directly or indirectly controlling, controlled by, or under common control with a Party.

b) "Confidential Information" means information of an Owner which relates, respectively, to the purpose stated in Section 2 below, including trade secrets, business and technical information and data, or which, although not related to such purpose, is nevertheless disclosed as a result of the Parties' discussions in that regard, and which, in any case, is disclosed by Owner or its Affiliate(s) to Recipient or its Affiliate(s) in document, electronic media, or other form bearing an appropriate legend indicating its confidential or proprietary nature, or which, if initially disclosed orally or visually is identified as confidential at the time of disclosure and a written summary thereof, also marked with such a legend, is provided to Recipient within fifteen (15) calendar days of the initial disclosure.

2. Use of Confidential Information. A Recipient of Confidential Information under this Agreement from the Owner shall use the Confidential Information solely (i) for the purposes of discussing and evaluating business opportunities between the parties relating to providing drug safety testing services, and (ii) to the extent that subsequent contracts, purchase orders or other agreements do not contain provisions relating to Confidential Information, or incorporate this Agreement by reference, for performing services pursuant to and within the scope of any subsequent contract, purchase order or other agreement.

3. Protection and Permissive Disclosure of Confidential Information. Recipient shall protect all Confidential Information from disclosure to any third party using the same degree of care used to protect its own confidential or proprietary information of like importance, but in any case using no less than a reasonable degree of care. Recipient may disclose Confidential Information received hereunder to (i) its Affiliates who agree, in advance, in writing, to be bound by this Agreement, and (ii) to its employees and consultants, and its Affiliates' employees and consultants, who have a need to know, for the purpose of this Agreement, and who are bound to protect the received Confidential Information from unauthorized use and disclosure under the terms of a written agreement. Confidential Information shall not otherwise be disclosed to any third party without the prior written consent of the Owner. Furthermore, Recipient agrees following disclosure of Confidential Information and for a period of two years thereafter that it will not directly or indirectly interfere with any contractual or business relationships existing between Owner and its employees, suppliers, consultants, clients or customers.

4. Exception to Restrictions. The restrictions of this Agreement on use and disclosure of Confidential Information shall not apply to information that:

- a) was publicly known at the time of Owner's communication thereof to Recipient;
- b) becomes publicly known through no fault of Recipient subsequent to the time of Owner's communication thereof to Recipient;
- c) was in Recipient's possession free of any obligation of confidence at the time of Owner's communication thereof to Recipient;
- d) is developed by Recipient independently of and without reference to any of Owner's Confidential Information or other information that Owner disclosed in confidence to any third party;
- e) is rightfully obtained by Recipient from third parties authorized to make such disclosure without restriction; or
- f) is identified by Owner as no longer proprietary or confidential.

5. **Obligations for Required Disclosure.** In the event Recipient is required by law, regulation or court order to disclose any of Owner's Confidential Information, Recipient will promptly notify Owner in writing prior to making any such disclosure in order to facilitate Owner seeking a protective order or other appropriate remedy from the proper authority. Recipient agrees to cooperate with Owner in seeking such order or other remedy. Recipient further agrees that if Owner is not successful in precluding the requesting legal body from requiring the disclosure of the Confidential Information, it will furnish only that portion of the Confidential Information which is legally required and will exercise all reasonable efforts to obtain reliable assurances that confidential treatment will be accorded the Confidential Information.

6. **Ownership of Confidential Information.** All Confidential Information disclosed under this Agreement shall be and remain the property of Owner. All such information in tangible form shall be returned to Owner promptly upon written request or the termination or expiration of this Agreement, and shall not thereafter be retained in any form by Recipient.

7. **Representations of the Parties.** Each Party represents that it has the right to make disclosures under this Agreement; that it will not disclose to the other any information confidential to any third party without authorization from that third party; and that the terms of this Agreement are not inconsistent with other contractual and/or other legal obligations it may have, or with the policies of any institution with which it is associated, including but not limited to, policies regarding the administration of grants and funded research.

8. **No Grant of Intellectual Property Rights.** No licenses or rights under any patent, copyright, trademark, or trade secret are granted or are to be implied by this Agreement. Neither Party is obligated under this Agreement to purchase from or provide to the other Party any service or product.

9. No Liability. Owner shall not have any liability or responsibility for errors or omissions in, or any decisions made by Recipient in reliance on, any Confidential Information disclosed under this Agreement.

10. Term of Agreement. This Agreement shall become effective as of the date first written above and shall automatically expire the later of (i) two (2) years from the date first written above and (ii) in the event that any subsequent contract, purchase order or other agreement is entered into by and between the Parties, which subsequent contract, purchase order or other agreement either does not contain provisions relating to Confidential Information or which incorporates this Agreement, six (6) months after the expiration or termination of such subsequent contract, purchase order or other agreement, provided, however, that prior to such expiration, either Party may terminate this Agreement at any time by written notice to the other. Notwithstanding such expiration or termination, all obligations hereunder shall terminate with respect to the disclosed Confidential Information after five (5) years from the termination or expiration of the Agreement unless such Confidential Information concerns a trade secret, in which case the obligations under this Agreement shall continue with respect to such trade secret for as long as such trade secret remains a trade secret.

11. Confidentiality of Discussions. Except upon mutual written agreement, or as may be required by law, neither Party shall in any way or in any form disclose the discussions that gave rise to this Agreement or the fact that there have been, or will be, discussions or negotiations covered by this Agreement.

12. Remedies. The Parties acknowledge that Confidential Information is unique and valuable, and that disclosure in breach of this Agreement will result in irreparable injury to Owner for which monetary damages alone would not be an adequate remedy. Therefore, the Parties agree that in the event of a breach or threatened breach of confidentiality, the Owner shall be entitled to specific performance and injunctive or other equitable relief as a remedy for any such breach or anticipated breach without the necessity of posting a bond.
